



### Chan Lee Taekwondo Waiver and Release

Every staff member, volunteer and student **MUST** read and understand this waiver and release before attending or participating in any Chan Lee Taekwondo activity or event.

1. By signing below, I confirm that I am the individual whose application is being submitted, and that I have read and understand this waiver and release.
2. I understand that this waiver and release is made for the benefit of Chan Lee Taekwondo, and each of its owners, masters, instructors, coaches, volunteers, business operators, agents, and site property owners or occupiers (collectively, the "Organization").
3. For all minor applicants the parent and/or legal guardian certifies that the information contained within this application is true, that they are aware of the applicant's intention to participate in this Organization's activities, and that the applicant does so with their approval and consent.
4. I understand that there are inherent risks associated with each of the following activities:
  - a. The martial art of taekwondo
  - b. The use of taekwondo equipment, whether it be owned by the Organization or your own
  - c. The use of the Organization's facilities
  - d. Participation in sport, fitness, instruction, and other activities, programs, or events provided or organized by the Organization.
5. I am aware that the risks include, but are not limited to, the potential or serious injury, death, or property damage. I understand the risks may be relative to my own state of fitness and health (including physical, mental and emotional), and to the awareness, care and skill with which I conduct myself.
6. I freely accept and fully assume all responsibility for all risks and possibilities of personal injury, death, property damage and other loss resulting from my participation in the above described activities. I accept these risks and agree to the terms of this waiver and release, even if the Organization is found to be negligent or in breach of any duty of care or any obligation to me in my participation in the activities.
7. In addition to consideration given to the Organization for my participation in activities, I and my heirs, next of kin, executors, administrators and assigns (collectively my "**legal Representatives**"), agree:
  - a. To waive all claims that I have or may have in the future against the Organization;
  - b. To release and forever discharge the Organization from all liability for all personal injury, death, property damage, or other loss resulting from my participation in the above described activities due to any cause, including but not limited to negligence

(failure to use such care as a reasonably prudent and careful person would use under similar circumstances) either passive or active, breach or any duty imposed by law, breach of contract or mistake or error of judgement of the Organization;

- c. To release and forever discharge the Organization from all liability for all personal injury, property damage or other loss resulting from any infectious disease, virus, bacterium, or other microorganism (whether asymptomatic or not); or
  - d. To release and forever discharge the Organization from all liability for all personal injury, death, property damage, or other loss resulting from Coronavirus (Covid-19) including any mutation or variation thereof; or
  - e. To release and forever discharge the Organization from all liability for all personal injury, death, property damage, or other loss resulting from a pandemic or epidemic, as declared as such by the World Health Organization and any government authority; and
  - f. To be liable for and to hold harmless and indemnify the Organization from all actions, proceedings, claims, damages, costs, demands including court costs and costs on solicitor and client basis, and liabilities of whatsoever nature or kind arising out of or in any way connected with participation in activities.
8. In submitting this waiver, I understand and agree to the following:
- a. The responsibility to read and understand how each of the Organization's competition or event policies apply to this specific event;
  - b. To abide by local, provincial, or federal safety protocols, including participation in 'physical distancing' in defense and mitigation of Covid-19; and
  - c. To receive email messages from the Organization, relating to events.
9. In consideration for the Organization's services in organizing the event, I hereby grant and assign to the Organization, without limitation, my individual television, radio, motion picture, print advertising, internet and all other related media rights with respect to my participation in Organization's activities and events.
10. In case of medical emergency during participation, I authorize a qualified medical doctor to take necessary measures in the treatment of this applicant.
11. I confirm that I have had sufficient time to read and understand each term in this Waiver and Release in its entirety and have agreed to the terms freely and voluntarily. I understand that this Waiver and Release is binding on myself and my legal representatives.

### Chan Lee Taekwondo Risk Acceptance Waiver

Every staff member, instructor, volunteer, and participant **MUST** read and understand this waiver before attending or participating in any Chan Lee Taekwondo training or event.

This declaration and acceptance of risk must be signed prior to attending or participating in any Chan Lee Taekwondo activity. Failure to do so will result in the participant's inability to attend or participate in any training, class, or related events. You agree to observe and fully abide by all rules and regulations prescribed by Chan Lee Taekwondo. Any failure to do so will result in immediate removal from participation or suspension from future classes. Covid-19 can be transmitted by asymptomatic people and accordingly the statements made by participants contained in this document cannot provide certainty that the virus will not be transmitted. Chan Lee Taekwondo is taking prudent steps to impose and enforce appropriate protocols to keep participants, family members, volunteers and club staff safe, but there can be no assurances that the virus will not be contracted by others. This is a risk that each participant must assess themselves, and if they choose to participate, take the risk of either contracting the virus or transmitting it to others.

#### **By completing and submitting this declaration you agree to the following:**

I hereby declare that neither I nor anyone in my household has experienced any cold or flu-like symptoms in the last 14 days (to include fever, cough, sore throat, respiratory illness, difficulty breathing or stomach cramps). If I or anyone in my household has experienced any cold or flu-like symptoms after submitting this declaration, I will then withdraw from participating in class or future classes within a 14-day period of time. ## Chan Lee Taekwondo Class Procedures

### GENERAL

- To protect yourself and others: practice physical distancing; wash hands often with soap and water for at least 20 seconds or use hand sanitizer; cover coughs and sneezes with a tissue or your arm; avoid touching your face with unwashed hands; watch for COVID-10 symptoms: cough, fever, shortness of breath, runny nose, or sore throat
- Participants must adhere to Chan Lee Taekwondo regulations in terms of access to facilities
- Participants are responsible for their own equipment at all times
- Congregating anywhere on Chan Lee Taekwondo property prior to or following class is prohibited

### EVENT PRE-ARRIVAL

- Waiver and Release, Risk Acceptance documents must be read, signed, and submitted to Chan Lee Taekwondo
- Check emails, and website for updates or notifications
- Read and follow directions in other notifications provided about booking procedures.

### ARRIVAL AND PREPARATION

- Instructor will be present to provide directions as students arrive
- Only students registered online will be eligible to enter the dojang, Parents or other spectators not allowed unless absolutely necessary and approved by the instructor.
- Please be no more than 10 mins prior to class time
- Read and follow the directions in other notifications provided about in class procedures.
